4. NSF cheques will be subject to a \$25.00 charge.
5. Failure to comply with these terms and conditions may result in cancellations of credit privileges without notice.
6. The applicant consents to allow Bradley Air Services to offset any funds owing by the applicant to Bradley Air Services with any funds owing by Bradley Air Services to the applicant.
7. Applicant agrees to bear all costs incurred in collecting any unpaid amounts including but not limited to, legal fees on a solicitor/client basis and court costs.
8. The information given by the applicant in this Credit Application and Agreement is warranted to be true, complete and correct and given for the purpose of obtaining credit.
9. The application consents to allow Bradley Air Services Limited to obtain from others such factual and investigative information regarding himself/herself as permitted by law.
10. The applicant consents to allow Bradley Air Services Limited to retain any information permitted by law for its record.
