# **NUNAVUT TRAVEL CHECKLIST**

If you are travelling to and from Nunavut, you must do these 4 things before your trip.

This information is subject to change without notice. Please check with the <u>Government of Nunavut</u> and the <u>Government of Canada</u> for the most current information.

Please <u>CLICK HERE</u> to review updated COVID-19 vaccination and/or testing requirements mandated by public health authorities departing from areas including select northern communities and southern hubs. These new requirements are in addition to existing requirements which have been implemented by Territorial and Regional Public Health Authorities. Failure to meet all of the applicable requirements before your flight will prevent you from travelling.

## **Check for updated information from the Government of Nunavut**

- Visit the Government of Nunavut website and confirm you are eligible to travel.
- The Government of Nunavut requires most travellers who are not fully vaccinated to quarantine for 10 days
  prior to entering the Territory. To schedule your stay at a quarantine hotel, download an <u>Isolation</u>
  Reservation Request Form and email to NUisolationreservations@Nunavutcare.ca.
- Certain types of travellers who are not fully vaccinated can apply for exemption from restrictions.

#### **Confirm Travel Authorization**

- Most travellers entering Nunavut must present proof of being fully vaccinated as per the Transport Canada requirements or provide a letter from the CPHO for Nunavut confirming their completion of a 10 day isolation.
- Alternative processes apply for travelers who are not fully vaccinated and qualify for an exemption from isolation requirements:
  - Exempt Critical Workers Form, submit to <a href="mailto:CPHOTravelRequests@gov.nu.ca">CPHOTravelRequests@gov.nu.ca</a>
  - Compassionate Exemption Form, submit to <u>CPHOTravelRequests@gov.nu.ca</u>
  - Common Travel Area Form, submit to CPHOTravelRequests@gov.nu.ca
- Additional authorization may be required for travel to communities that have travel restrictions. Check the Government of Nunavut website to confirm if this applies to your travel.

## Bring a mandatory non-medical mask or face-covering

- The Government of Canada requires all travellers to confirm that they have a mandatory non-medical face
  mask in their possession during check-in more information here.
- Please note that as shown in the above link, face coverings with an exhalation valve or vent, non-medical
  masks/face coverings made with mesh or lace fabric, neck gaiters, bandanas and face shields will not be
  accepted as they don't protect others from COVID-19 and don't limit the spread of the virus.
- Travellers who do not have a suitable face covering in their possession will not be allowed to fly.
